1. Introduction

2. What Are Cookies?

Cookies are small text files that are placed on your computer, smartphone, or other device when you visit a website. They help the website recognize your device and remember information about your visit, such as your preferences and settings.

3. What Types of Cookies We Use

We use the following types of cookies:

- **Strictly Necessary Cookies:** These cookies make the site usable by enabling basic functions like page navigation and access to secure areas. The website cannot function properly without these cookies.
- **Functional Cookies:** These cookies allow the website to remember information that changes the way the site behaves or looks, such as your preferred language or the region you are in. Legal basis: Article 6(1)(f) of the General Data Protection Regulation (GDPR); Article 43(2) of the Electronic Communications Act.
- **Analytical Cookies:** These cookies help website owners understand how visitors interact with websites by collecting and reporting information anonymously. Legal basis: Article 6(1)(a) of the General Data Protection Regulation (GDPR); Article 43(4) of the Electronic Communications Act.
- **Marketing Cookies:** These cookies are used to track visitors across websites. The intention is to display ads that are relevant and engaging for the individual user, which is important for third-party advertisers and publishers. Legal basis: Article 6(1)(a) of the General Data Protection Regulation (GDPR); Article 43(4) of the Electronic Communications Act.
